Potential Health Effects

Primary Entry Routes: Eyes, skin, lungs.

Target Organs: Eyes, lungs.

Acute Effects

Inhalation: Excessive inhalation of vapors can cause nasal and respiratory irritation, central nervous system effects including dizziness, weakness, fatigue, nausea, and headache. Symptoms of exposure may include burning sensation, coughing, wheezing, laryngitis, shortness of breath, headache, nausea, and vomiting.

Eye: Can cause severe irritation, redness, tearing, blurred vision.

Skin: Skin absorption can exceed TLV. Irritation can occur.

Ingestion: Can cause gastrointestinal irritation, nausea, vomiting, diarrhea, blindness, and death.

Carcinogenicity: IARC, NTP, and OSHA do not list components at concentrations above 0.1% which are considered as a possible carcinogen.

Engineering Controls:

Administrative Controls:
